- The Library received a donation of power tools that is being considered as an addition to the Library of Things. Margaret suggested that a waiver of liability might be necessary.
- Hybrid programs (in person and online) have been well-attended and there may be more programs using this format in the future.
- Many attended the Friends annual tea and there was unanimous praise for the program on the women's suffragist movement in Vermont and songs created around the movement.
- Rachel attended the Washington County Library Directors meeting.
- The "stuffie sleepover," for children's <u>second</u> favorite stuffed annimal (the most favorite staying at home for comfort) was a big hit! After the Library closed for the night, Roeki and Cynthia took pictures of all of the stuffies' antics.
- The Waterbury Roundabout this week featured an article on the Library's successful Queer Reads program. A cartoonist at the last meeting was very popular.
- Well-attended adult programs last month included one on rain gardens, another on object-centered poetry, and many that were on-going. There is also a new regularly scheduled group on rug hooking.
