Public Works Update: B. Woodruff reports the roads are open now except River Road to the Ice Center. Crews are working on clean up and street sweeping. At least three homes with basements flooded. Water and Wastewater crews were out all night with high amounts of effluent. Highway crews are dealing with gravel road issues related to rain. There is some road damage near the Winooski Street bridge. Storm drainage system did well in the village. Contractor will be coming in to look at the bridges on Armory Drive and Union Street. Bridges on Guptil Road fared well.

Two vehicles that were submerged by the roundabout have been towed.

Power is okay in most of the houses.

L. Schlegel on behalf of CReW – volunteers are currently gathering information. Help was offered yesterday to move things up from basement. Healy Court, Elm Street, Union Street, South Main and Route 2 were hit hard. Vactor Trucks and sump pumps are needed. Muck out and clean-up efforts are being organized. Some of the houses that have just been repaired are now damaged again.
