<u>Consider Modifications to the Agenda</u>: W. Shepeluk requested time on the agenda to update the commissioners on the Ice Center UDAG Loan and a Farmer's Market permit for Smuggler's Notch Distillery. By consent this will be added to the agenda.

Consider Solar Panel Proposal: W. Shepeluk provided an update and overview of the discussions with P. Krolczyk, Wastewater Treatment Operator, regarding the installation of solar panels at the facility. W. Shepeluk needs time to determine if EFUD can use any of the power generated by the array - he feels this is benefit to EFUD's involvement. C. Parson's has agreed to increase the lease payment to 7.5% for a term of 25 years. C. Parsons tasked with drafting a lease agreement.

<u>Consider Motions for Annual Meeting:</u> Overview of the articles on warning for the annual meeting this evening.

Consider funding for archeological contract: S. Lotspeich spoke to the commissioners regarding an archeological site near the Ice Center known as the Lamson/Batcheldor site. Hartgen Archeological Associates Inc. had previously been contacted to conduct Phase II survey of this site. N. Sherman made a motion to authorize the contract to move forward under the Utility District in the amount of \$12,597.00 C. Parks seconded the motion; a vote was held and passed unanimously

<u>Consider Managers Compensation</u>: L. Sayah has volunteered to work on a committee, along with two members of the Select Board to determine the Municipal Managers compensation for 2019

Smuggler's Notch Distillery / Farmer's Market Permit: Smuggler's Notch Distillery has been awarded a Farmer's Market permit allowing them the sale of spirits at the Farmer's Market in Waterbury. W. Shepeluk wanted the Commissioners to be aware of this as it would seem no permission from them is necessary. C. Lawrence will follow up with the market organizers and Vermont Liquor Control for more details of the permit and update the board

<u>UDAG Loan – The Ice Center</u>: W. Shepeluk updated the Commissioners on the progress of the additional \$200,000 UDAG loan with the Ice Center. The District requested and received a letter from the Community National Bank confirming the loan the Ice Center has with them will be re-amortized. C. Parks made a motion to allow the amortization and the accrual of interest of the Utility District UDAG loan to the Ice Center to begin on May 15, 2019, waiving interest from April 29 – May 14, 2019. L. Sayah seconded the motion; a vote was held and passed unanimously.

Wastewater Progress Report May 2019

• Process:

- o CoMag process running well. Solids wasting from the process has now been changed from the continuous mode based on influent flow percentage to batch wasting based on 500 gallons per every 10,000 gallons. This change is appearing to reduce magnetite loss.
- o Work on L2-4 lagoon motor VFD continues; fuses continue to blow. All other lagoon motors and Grid Bee circulators running well.
- o Residuals: sludge testing continues. Total Leachate Characteristics Potential (TLCP) has been completed. PFOA testing on the sludge will begin this week. The goal will be to comingle the three WWTP waste stream sludges and to transfer contents to Canada though Englobe, for beneficial use.
- o Moving forward to purchase the sludge pump removal barge and sled for periodic sludge removal from Lagoon #1 with objective to eliminate a full Lagoon cleanout.
- o Monthly Flows April

Influent: 12.80MG, Effluent: 12.30 MG Precipitation: 7.00 inches



Summary

Near the beginning of April, we closed the collection lines at the dams and opened the bypasses. We did this due to several heavy rain events which stirred up a lot of sediment in the surface water, as well as to allow high flows to clear some collected debris out of the dams. Fortunately, with all of the snowmelt and high water tables, we have been able to operate the plant using only spring water for most of the month.

With the Main Street project beginning in earnest this month, we spent a lot of time carefully marking the water system in the affected area, including all curbstops, valve boxes, hydrant valves, etc. The ones which would need to be operated in the event of a break during construction were marked and tested to ensure they are in good working order.

Along similar lines, we met several times with the J.A. McDonald crew to coordinate scheduling and get an understanding of the scope of work coming up, as well as to walk the water system with them so that they are as familiar as possible with it while working on it or working around it.

We have also been working to get the Hach service plan on plant instruments going. The main slowdown on that front has been coordinating between Hach and the State of Vermont on the fluoride meters, because the state is able to cover the payments in support of the fluoridation program, but it gets a little tricky to coordinate paperwork and invoicing with a third party involved. That will be wrapping up very soon though, and we anticipate that will be finalized during the month of May.

There's some work being done at the pool building to prepare for summer. We've assisted on several fronts with that project, from turning on the water to the building, to moving equipment that was in the way of renovation work, to picking up and transporting toilets to be installed.

There was a new tap-on on Hollow Road in the Center in April. The Lavanway's tapped on after an issue with their well. This was an interesting one, as the connection was made after directional boring under the road. It all went smoothly, and they are now on the system as new customers.

Woody and Scott attended a VOSHA training in Essex which was very helpful in fine-tuning some procedures and systems in place surrounding safety issues. While we already do prioritize safety and feel that we do a very good job with it, the training did highlight a couple of things we'd like to add to our protocols, such as written evaluations of confined spaces detailing why we classify certain ones as permit required or exempt. Most of this stuff is simply an added layer of security on top of existing protocols, but seems like a great opportunity to expand upon them. Matt attended the same class in early May.

Finally, we spent much of the final week of April on spring meter reading. As usual, we enjoy this meter reading much more than the mid-winter meters. We anticipate the meters will be read by early May, and rereads finished by the middle of the month.

Sweet Wells were using during April; Well 1 was not. The Sweet Wells were used on 10 days with an average flow of ~180gpm for a total flow of ~1,935,000
