Scale- still in the planning stages, all concrete, will have some engineering involved for drainage, etc. Process is 3-4 months, environmental aspects- was a hazardous waste site in the past but it received site management approval- no health and safety concerns. 15,000 square feet for the whole build out.
- iii. Operation and Management planning-a possible revenu process from the community. Minimal upkeep with a concrete skatepark. Building and maintenance will be provided by the skatepark committee. Will have a group like WATA who will provide oversight. Will address many of these concerns with an MOU. Next steps are to see if the town accepts the land from EFUD.
