5. Recreation center/Pool discussion design -

Consider identifying our population, what could we attract with different levels of facilities, start to put a dollar value on these and what kind of ROI would be.

Town is in a contract with Wyman and Lamphere-(designed the fire station) for \$17,500 and they will work on conceptual design and schematics for a new recreation facility. Only looking at Anderson Field property. Don't have the budget to make this an extensive building with community partners.

Building and Pool: Voters approved 55K to resurface the pool at Town Meeting. Considering new filter for 2026 and additional resurfacing. We will keep limping along since the cost is extraordinarily high for replacement.

Can work on the study over the course of the next 6 mos and then seek community desire/support to be able to move to the engineering phase. Design a basic building in line with what we can afford.

We need more data about community support for this project.
