Jan 26, 2015 a) FINALIZE POLICY DISCUSSION (Possible Public Meeting) - PC will finalize discussion of the policies regarding developing in the floodplain that will provide the basis for re-writing the Flood Hazard Area Regulations. Wrap up the discussion regarding mapping and regulation for the 100-year and possibly the 500-yr. floodplain, and how to regulate different types of uses and development in the floodplain such as commercial/industrial/residential and critical facilities.

b) REVIEW OUTLINE OF DRAFT FLOOD HAZARD AREA REGULATIONS – Review draft outline of options for flood hazard area regulations prepared by staff.
