Time Line for Drafting and Approving Flood Hazard Area Regulations

Jan 26, 2015 a) FINALIZE POLICY DISCUSSION (Possible Public Meeting) - PC will finalize discussion of the policies regarding developing in the floodplain that will provide the basis for re-writing the Flood Hazard Area Regulations. Wrap up the discussion regarding mapping and regulation for the 100-year and possibly the 500-yr. floodplain, and how to regulate different types of uses and development in the floodplain such as commercial/industrial/residential and critical facilities.

b) REVIEW OUTLINE OF DRAFT FLOOD HAZARD AREA REGULATIONS – Review draft outline of options for flood hazard area regulations prepared by staff.

February 9, 2015: REVIEW DRAFT FLOOD HAZARD AREA REGULATIONS – Review draft regulations prepared by staff

February 23, 2015: FINALIZE DRAFT REGULATIONS – Finalize 1st draft of Flood Hazard Area Regulations and advertise public hearing.

March 23, 2015: PC PUBLIC HEARING ON DRAFT REGULATIONS – Revise PC draft regulations based on comments from public, municipal attorney, and state

April 13, 2015: PC PUBLIC HEARING ON REVISED DRAFT REGULATIONS – Finalize and approve final PC draft regulations and transmit to Select Board and Trustees

April 20, 2015: PC PRESENTATION OF DRAFT REGULATIONS TO SELECT BOARD AND TRUSTEES – Select Board and Trustees set date for their public hearing

Mid-May 2015: SELECT BOARD AND TRUSTEES HEARING ON DRAFT REGULATIONS

Mid-May 2015: SELECT BOARD AND TRUSTEES FINALIZE AND ADOPT NEW REGULATIONS

May 21, 2015: INTERIM REGULATIONS EXPIRE, NEW REGULATIONS APPROVED

FUTURE CONSIDERATION: Review FEH mapping and consider draft FEH zone regulations.
